| NQ-006 | Compliance to the requirements of ISO9001, as a minimum, is required. For distributors AS9120 Certification is required. |
| NQ-007 | This work shall not be transferred to another supplier without the prior approval of Norris Precision and/or its customer |
| NQ-008 | Specification and current revision must be on Certificate of Conformance - C of C must be signed by approved representative with name and title typed or printed clearly The supplier shall provide provisions in the subcontracts to allow Norris Precision Mfg., their customer, and regulatory authorities right of entry to any place necessary to determine and verify the quality of contracted work, records and material. Records for Supplier shall be maintained and retained for a minimum of eleven (11) years, or longer per specific customer requirements. Supplier must have documented procedures for records management and retention inclusive of disaster prevention. If the supplier ceases trading with NPM, or the supplier is unable to maintain the records, the supplier shall provide the option for NPM to take possession of the records. Records are not to be destroyed without written approval from NPM Quality Manager. NPM shall maintain the right to access all or any portion of records. If a Supplier chooses not to retain records for the retention period specified, NPM Quality Manager must be notified in writing of the planned destruction. NPM Quality will provide a response in writing related to obtaining hard copy or electronic versions of the records. Supplier and/or sub-tier should not destroy until NPM response has been received and instructions enacted. |
| NQ-009 | GOVERNMENT RATED CONTRACTS - Rated orders are identified in the purchase order by a priority rating consisting of the rating - either DX or DO - and a program identification symbol. Rated orders take preference over all unrated orders as necessary to meet required delivery dates. Among rated orders, DX rated orders take preference over DO rated orders. Suppliers are required to flow the rating to sub tiers for the item they need to fill the orders. This provision ensures that suppliers will give priority treatment to rated orders from contractor to subcontractor to suppliers throughout the procurement chain. |
| NQ-010 | Export Compliance - Some of the purchase orders issued by Norris Precision Mfg. are in support of government contract programs. The technical data provided by Norris for these programs is subject to the restrictions and regulations of either the International Traffic in Arms (ITAR) or Export Administration Regulations (EAR) jurisdiction. The supplier hereby represents and agrees that all technical data provided by Norris Precision Mfg. in support of these programs will be used in strict compliance with the regulations set forth in the ITAR or EAR regulations and solely used for the performance of the work hereunder. The supplier further agrees to implement any necessary procedures for restricting access to said technical data to U.S. Persons only. If during the performance of the contract, the supplier is required to provide such technical data, or part thereof, to a sub-tier supplier, the supplier may do so provided that the sub-tier supplier is considered to be a U.S. Person and that the supplier imposes all the same restrictions contained herein upon the sub-tier supplier. Disclosure and access to said technical data by a foreign national is subject to any restrictions or licensing requirements of the organization with jurisdiction over the program (ITAR or EAR). Supplier shall, upon completion of the contract hereunder, including any warranty period, ensure that any technical data is either destroyed or returned in whole to Norris Precision Mfg. |
